This contract is agreed by both parties for the purpose of the breeding of the mare by fresh cooled or frozen semen according to following conditions:

- 1. Mare owner provides a copy of "Certificate of Registration" of the mare. (Prior to signing the contract)
- 2. Stallion owner is obliged to provide the stallion for the insemination, meaning they must provide fresh cooled or frozen semen.
- 3. Stallion owner confirms that the stallion fulfilled all conditions stated by AQHA/APHA as a breeding stallion or will arrange all necessary steps to enable the foal to be registered in AQHA/APHA.
- 4. Stallion owner confirms that the stallion was tested by AQHA 5 panel N/N and IMM N/MY.
- 5. Stallion owner does not guarantee the successful breeding depending on the mare, disorders of the reproduction cycle, disease of the sexual system etc.
- 6. Mare owner is obliged to pay the breeding fee for the year 2024, paid to the bank account at the date of signing this contract or at the latest 1 week after the signature. The first collection fee is included.
- 7. Breeding fee includes costs fee for the breeding report to AQHA and APHA.
- 8. Transportation costs for the semen are paid separately by the mare owner. Stallion owner is not responsible for the worse quality or damage of the semen during the transport.
- 9. Stallion owner guarantees the quality of the semen only at the time of the takeover to the transport.
- 10. Stallion owner provides delivery of the semen in case of unsuccessful breeding within year 2024 for the fees stated above, but the mare owner is obliged to inform the stallion owner about it by 31 October 2024 at the latest.
- 11. Stallion owner is not responsible for the injuries, disease or death of the mare cause by the breeding and foaling.
- 12. Other conditions are in line with legal framework valid in Denmark.

The contract is printed in 2 versions, one provided to the mare owner and second is kept by the stallion owner.

With the signature the mare owner declares that he or she accepts the breeding conditions.
